Remarks hereto:

Since the official publication of the Legal Councils decision on 24.12.2016, the deadline for introducing candidatures of two months was well known by all candidates.

Only the candidature N° 1 was submitted within deadline.

(*) The candidature of N° 2 was received 1 minute after deadline, but was considered in due time following the proofs presented by E-Mail: Sent at 23:59.

The candidature must be submitted according to § 10, point 1 of the Rules for GA by an ordinary member. (a Federation). This is not the case for candidate N ° 2, who proposed himself and submitted his candidacy on ordinary blank paper. (Without federation header)

Only the candidates N ° 1 and N ° 2 presented a program, it remains to specify that the program submitted by the candidate N ° 2 has not been submitted in the 3 INF-FNI languages as required by the § 18 of our Statutes. This candidate's program also contains an incorrect statement regarding the minutes of the LC of December 19th, 2016.

Considering that:

- Candidature N ° 1 corresponds to all requirements;
- Candidature N ° 2 & 3 do not meet the requirements;
- The EC, as organizer, must comply with the requirements of the Legal Council, the Statutes and the Regulations for AG;
- The Legal Council has approved these specifications,
